

#### Introduction

The following measures are in place to ensure the decision making process of the Board is subject to independent judgments:  • a standard item on each Board Meeting agenda requires directors to focus on and declare any conflicts of interest in addition to those already declared;  • directors are permitted to seek the advice of independent experts at the Company's expense, subject to the approval of the Chairman;  • all directors must act at all times in the interest of the Company; and  • directors meet as required independently of executive management.
